2B. Project Description

1. Provide a description that addresses the entire scope of the proposed project and how the Collaborative Applicant will use grant funds to comply with the provisions of 24 CFR 578.7.

The Indianapolis CoC Planning Grant will support continued work on the development of the systemic supports that ensure homeless assistance is well coordinated, well managed, inclusive, transparent, and achieves positive outcomes. We will continue supporting our framework for a comprehensive, well-coordinated and clear planning process. We have been operating within this framework since mid-2013. The CA will sub-contract the planning funds to the Coalition for Homelessness Intervention and Prevention, CHIP. CHIP serves as the lead entity for planning and advocacy for homelessness intervention and prevention in Indianapolis. The goal of this planning grant is to continue to improve system coordination of homeless assistance and mainstream housing and service providers to ensure that people experiencing homelessness receive assistance as quickly as possible and that the assistance is focused on helping them obtain and retain housing. We will coordinate with other systems of care that serve people who are homeless. We will continue the implementation of a strategy that is inclusive of representatives from both the private and public sectors. Under the 2016 NOFA, we were awarded a planning grant that included funds for planning for determining the evaluation plan and success measures related to coordinated entry, and integrating these activities into the CES services funded through the FY 2016 SSO grant. These activities were achieved and will continue with the SSO grant for Coordinated Entry. In 2018, FTEs funded through this planning grant will complete the following activities

- Support the CoC operation and management,
- Work to expand supportive services models,
- Plan the local SOAR initiative,
- Coordinate with LGBTQ providers to develop service recommendations,
- Coordinate with DV providers to ensure survivor specific policies and practices are in place,
- Implement the new community strategic plan,
- Develop and implement monitoring practices for ESG and CoC providers, and
- Coordinate with the Department of Corrections to create reentry strategies that keep people from becoming homeless,
- Complete the PIT count,
- Complete the annual GAPS analysis, and
- Continue COC board planning.

2. Describe the estimated schedule for the proposed activities, the management plan, and the method for assuring effective and timely completion of all work.

Immediately upon contract execution, the work activities under this planning grant will be transitioned into from activities undertaken with the 2016 planning grant. FTEs already undertaking planning activities will be assigned to those identified here. Since we already have in place a comprehensive, well-

coordinated, and clear planning process, we will be able to incorporate and transition work activities seamlessly.

Estimated timelines:

- Support the CoC operation and management (Ongoing 2018-2019)
- Work to expand supportive services models (December 2018)
- Plan the local SOAR initiative (Ongoing 2018-2019)
- Coordinate with LGBTQ providers to develop service recommendations (August 2018)
- Coordinate with DV providers to ensure survivor specific policies and practices are in place (August 2018)
- Implement the new community strategic plan (Ongoing 2018-2019)
- Develop and implement monitoring practices for ESG and CoC providers (January 2019)
- Coordinate with the Department of Corrections to create reentry strategies that keep people from becoming homeless (July 2019)
- Complete the PIT count (January 2019)
- Complete the annual GAPS analysis (August 2018)
- Continue CoC board planning (Ongoing 2018-2019)

The project will be managed by the Executive Director at CHIP in consultation with the CoC, the Blueprint Council (responsible for day-to-day activities of the continuum), and the four sub-committees of the Blueprint Council. Meetings will be held weekly with the FTEs funded through this grant, the Executive Director at CHIP, and any other relevant parties to review work and progress, and adherence to timelines. 24 CFR Part 578, the NOFA for the 2016 CoC Program Competition, and the HUD issued document Establishing and Operating a Continuum of Care will serve as the primary references and guidelines for implementing this project and ensuring timelines that complete the work during the 12-month grant time period.

3. How will the requested funds improve the CoC's ability to evaluate the outcome of CoC and ESG projects?

Outcomes monitoring is currently in place for CoC projects, and we are currently working to incorporate ESG projects by the end of CY 2017. Monitoring meetings take place every quarter where every CoC provider attends and reviews their own data, as well as community data for the last quarter. Outcomes measures for these meetings are currently based on our standard CoC program Scoring Tool. FTEs funded through this grant will update those policies, create new outcomes measures and review the measures currently in place, and coordinate with community members and HMIS staff to ensure data quality and opportunities to improve outcomes are understood. They will also continue to work with the CES team to develop outcomes measures and monitoring policies related to Coordinated Entry.

4. How will the planning activities continue beyond the expiration of HUD financial assistance?

The Indianapolis CoC receives ongoing financial support from local philanthropy in support of our community plan to prevent and end homelessness. While we

would have to reduce staffing without this financial assistance from HUD, CHIP would continue to continue planning activities using ongoing private funding that it currently receives for this purpose.

Through the eligible CoC grant administrative dollars to the Collaborative Applicant, staff will continue to support the planning process and implement these procedures in collaboration with the CoC sub-committees and the HMIS Lead. Should planning grants be eligible under future NOFAs we will apply for additional planning support to continue and expand these and other efforts. Other funding opportunities will be pursued as need dictates and those opportunities are identified.

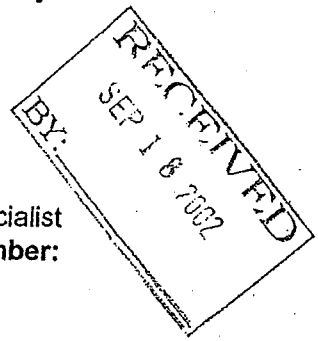

This letter is in response to your request for a copy of your organization's determination letter. This letter will take the place of the copy you requested.

Our records indicate that a determination letter issued in January 1989 granted your organization exemption from federal income tax under section 501(c)(3) of the Internal Revenue Code. That letter is still in effect.

Based on information subsequently submitted, we classified your organization as one that is not a private foundation within the meaning of section 509(a) of the Code because it is an organization described in sections 509(a)(1) and 170(b)(1)(A)(vi).

This classification was based on the assumption that your organization's operations would continue as stated in the application. If your organization's sources of support, or its character, method of operations, or purposes have changed, please let us know so we can consider the effect of the change on the exempt status and foundation status of your organization.

Your organization is required to file Form 990, Return of Organization Exempt from Income Tax, only if its gross receipts each year are normally more than \$25,000. If a return is required, it must be filed by the 15th day of the fifth month after the end of the organization's annual accounting period. The law imposes a penalty of \$20 a day, up to a maximum of \$10,000, when a return is filed late, unless there is reasonable cause for the delay.

All exempt organizations (unless specifically excluded) are liable for taxes under the Federal Insurance Contributions Act (social security taxes) on remuneration of \$100 or more paid to each employee during a calendar year. Your organization is not liable for the tax imposed under the Federal Unemployment Tax Act (FUTA).

Organizations that are not private foundations are not subject to the excise taxes under Chapter 42 of the Code. However, these organizations are not automatically exempt from other federal excise taxes.

Donors may deduct contributions to your organization as provided in section 170 of the Code. Bequests, legacies, devises, transfers, or gifts to your organization or for its use are deductible for federal estate and gift tax purposes if they meet the applicable provisions of sections 2055, 2106, and 2522 of the Code.
