Coburn Place proposes to expand its Transitional Supportive Services to include the Rapid Re-Housing and Advocacy Program and requests funds from the HUD Continuum of Care for this project.. Clients meeting eligibility requirements for this program will have fewer self-sufficiency barriers and domestic violence lethality than those clients residing in the Coburn Place facility.

Once in a rental unit, clients will work closely with an Advocate to access supportive activities within Coburn Place’s four pillars, including: 1) Immediate and Long-Term Safety; 2) Social and Emotional Well-Being; 3) Housing Readiness; and 4) Self-Sufficiency.
