Not all units are rented at Fair Market Rent, clients sometimes rent apartments under FMR and those with income contribute 30% of their income to their rental.

The Damien Center’s Housing Assistance Program serves the function of placing HIV-positive men, women, and children in safe, affordable housing of choice. The program implements an individualized support plan to maintain permanent housing and promote self-sufficiency for each client served. Housing Case Managers, in partnership with other case managers at The Damien Center and other sites, connect clients with supportive services necessary for them to gain stability and promote sustainability of the positive outcomes achieved by clients. Some of these supportive services include mental health and substance abuse counseling, medical case management, career development services, housing and emergency financial assistance, a food pantry, and transportation assistance. The agency also offers comprehensive HIV prevention services, including free HIV counseling, testing and referral; STD and pregnancy testing; and prevention counseling and education. Damien Cares, a registered non-profit organization co-located with The Damien Center, offers individuals living with HIV access to infectious disease care and primary care, as well as PrEP and PEP for those at substantial risk for contracting HIV. Housing units provided through this program are offered at sites scattered throughout the Indianapolis area, totaling 45 units.
