Funds were returned because Midtown was guided by HUD field office and the City of Indianapolis that it could not add additional participants on the grant to spend down funds. In late November 2016, Midtown was told it could do this and began addition persons immediately. Drawdown rates have improved significantly. Midtown expects to have 90%- 100% drawdown rates in the next 12 months.

The grant provides 50 scattered site units of Permanent Supportive Housing for chronically homeless individuals where the applicant has a disabling condition of serious mental illness and/or substance use disorder. Applicants are selected through the Indianapolis Coordinated Entry System. A Housing Case Manager and Community Support Specialist work in tandem to assist the applicant in locating housing that best meets their individual needs; work with landlords to understand the program; advocate for the applicant/participant and resolve any issues upon rental and during lease period; conduct inspections; assess applicant/participant for needs such as employment; SSI/SSDI; community supports; food; transportation; child care, etc. and link applicant/participant to those services and supports in the community as applicant is willing. Work with applicant/participant toward engagement in mental health and/or substance use disorder services as needed and as applicant/participant is willing. Continue contact with participant and resolve any issues that may lead to loss of housing throughout the program.
