Point in Time Discussion	Emily	Review of Point in Time process, timing, and federal requirements 2018 PiT 6% lower than 2017; review of subpopulations Unsheltered number went up slightly, but sizeable decrease in the sheltered count Question regarding increased funding for change in count? Not necessarily; questions in the NOFA but one small piece of a large application
HMIS & Boardable	Brian	Brief introduction to the HMIS database (Homeless Management Information System) – HUD requirement for outcomes and funding Discussion of Coordinated Entry System (CES) and how housing is now accessed, how status in the pool changes and what documentation is needed Requests for additional information/training on HMIS and CES

Camp Closings	Brian	FBOT coordinating with PBSO due to frequent closures/movement CSX closed the zoo, most have moved near the river Fern is closing, one couple is slated for housing but the unit did not pass inspection
